1. 2022 Budget Work Session

Finance Director Dee Anne Grunder went through some highlights on the 2022 Budget. She stated there was an increase of 8.62in the assessed valuation. Ms. Grunder stated the mil levy is the same as last year at 44.643. She stated other changes that were made, and they include:

- 4.16% cost of living adjustment.
- Transfers to the vehicle and IT replacement plans.
- Created a new law enforcement department for spending fund earmarked under the tax lid.
- \$750,000 budgeted in the General Fund from the Casino.
- Transfer of \$300,000 budgeted in the Capital Project Fund for financial software.
- Year end transfer not to exceed \$500,000 budgeted for the replacement plans.
- \$50,000 added to Parks budget for park improvements.
- Governing Body salary increase of \$10,200 for the Mayor, \$5,200 for Council President, and \$4,550 for Council Members.
- Budgeted part-time Building Inspector was increased to fulltime.
- 3 new Public Works positions added: Park Maintenance Tech 1, Water/Sewer Tech 1, and Street Tech 1.

A discussion ensued on the highlights Ms. Grunder addressed. All Council Members were satisfied with the changes.

Council Member Ben Sauceda moved to adjourn the meeting at 6:28 pm.

Council Member John Lehnherr seconded the motion. Motion carried 6-0.
